On July 9, 2012, the Immigration Law and other relevant rules have been revised, and procedures for foreign nationals living in Japan have also been changed. Details for Special Permanent Residents are different from the following information. Please inquire (5) below, or the Resident Register Subsection for more details.

Outline of Changes applicable as of July 9, 2012:

- A. The new system applies only to foreign nationals with legal residence status of over 3 months. Those with no residence status or with only "Temporary Visitor" (*tanki taizai*) status are not included.
- B. A new Residence (*zairyu*) Card is issued to replace the old Alien Registration Card.
- C. Eligible foreign national residents are recorded on the Resident Record (*juminhyo*) same as Japanese nationals.

(1) Important Reminders for Residence (*zairyu*) Cards Holders

① Notification of Address

You are required to notify your local municipality of your address in person within 14 days once you have decided the residence, bringing the Resident Card and relevant documents with you. If you fail to notify of your address within 90 days of arriving in Japan without a valid reason, your residence status may be revoked.

② Obligation to Carry Residence Card At All Times

You are required to carry your Residence Card with you at all times while in Japan. However, this rule does not apply to minors aged under 16 years old.

③ Renewal or Change of Resident Status

Renewal and change of resident status procedures are proceeded by the Immigration Services Agency. When you have renewed or changed your resident status, the Immigration Bureau notifies your local government of the changes. You do not need to carry out any particular procedures for renewal or change of resident status at your local government office. However, you may need to carry out related procedures which arise as a result, e.g. renewal of period of validity of National Health Insurance card at the local government office.

(2) Procedures related to Resident Records (*juminhyo*)

If you move to a different municipality (city, town or village), you need to get a Moving Out Certificate (*tenshutsu-todoke*) from your current local government, and then submit a moving in report (*tennyu-todoke*) to the local government of your new residence.

For moving in and moving out reports procedures, you need to bring the Residence Card(s) for all members of your household who move.

Those with no residence status or with only "Temporary Visitor" status are no longer recorded in the Resident Register and not entitled to get Resident Record copies or register a personal seal (*inkan toroku*).

(3) Locations for various procedures or applications

Regional Immigration Services Agency	Changes to resident status or period, re-issue of Residence Card, changes to name, nationality, etc, application for kanji name
Local Governments	Moving in/moving out reports, change of address, change of head of household, etc. Copies of Resident Record

(4) The New Re-Entry Permit System

A Re-entry Permit is no longer required in principle when a foreign national with a valid passport and Residence Card re-enters Japan within one year of leaving. However, a person who leaves Japan without a Re-entry Permit is not able to extend the validity period of the permit while outside Japan. Also, please note that the visa is to be invalidated if you do not return within one year.

※ If your visa term is to be expired in less than one year from departure date, please return by the expiration date. Please present the Residence Card when leaving Japan. For more details, inquire Regional Immigration Services Bureau.

(6) Returning the Residence Card

Foreign nationals are required to return their Residence Card if it has become invalid under the following circumstances: when they are no longer covered by the system; or when they exit Japan with a Re-entry Permit and do not return within the validity period of the permit. The Cards must be returned to the Regional Immigration Bureau within 14 days of becoming invalid. Cards may be returned in person to the Regional Immigration Services Bureau with jurisdiction over the applicant's resident address, or by mail to the address below. Fines may be imposed for failure to return a card by the specified date.

(7) Requests for Disclosure of Recorded Information

With the implementation of the new registration system on July 9, 2012, the Alien Registration System was abolished. Certificates of Recorded Matters (aka, Certified Copy of Foreign Registration Details) are no longer issued by local governments accordingly. For certification of information recorded prior to July 8, 2012, inquire the following office. Requests may also be made by mail as well. It may take time for issuing the certificate. (9) Naturalization

About Registered Seals

Seals (*inkan*) are used on official documents in the same way as signatures in Japan. You may purchase one or have it made at seal stores. By registering the seal at City Office (*inkan toroku*) a certificate of seal registration (such “registered seals” are called *jitsuin*) is issued. This is required for important transactions such as motor vehicle registration, real estate registration, loan guarantees, notarized documents, etc.

Please bring the seal to be registered to the Family Registration Section at City Office, or any Residents' Office, along with your Residence card or Special Permanent Resident card. If an application is made by proxy, a letter of authorization holographed by the owner of a seal is required. In order to qualify for registration, seals must meet certain conditions; please inquire the Resident Transfer Subsection for details.

In case of moving into Itabashi from other municipality, seal registration in the previous municipalities canceled upon registration of change of address, and it needs to be newly registered in Itabashi. In case of moving out of Itabashi, you are requested to return your Itabashi Residence Card or seal registration card to City Office when you move out.

Upon confirming that you are pregnant, please submit a Notification of Pregnancy to the Certifications Subsection, Family Registration Section at City Office, South Building (1F), your local Health and Welfare Center or Citizens' Office. The notification forms are available at the counters. You will receive a Mother and Baby Health Bag which includes a Maternity Record Book and maternity health checkup coupons, etc. Maternity Record Books in English and Chinese are also available at the Health Promotion Section and Health and Welfare Centers. For Maternity Record Books in other languages (Korean, Thai, Tagalog, Spanish, Portuguese, Indonesian, Nepali, Vietnamese), please inquire at the Health Promotion Section.

(2) Pregnancy and Childbirth “Navigation” Project (Interview with expecting mothers)



An application for **permanent residency** needs to be made within 60 days of birth. Applicants are requested to bring proof of birth registration (*shussho todoke juri shomeisho*) and certificate of residence (*juminhyo*) to the Resident Register Subsection (1F, South Bldg, City Hall).

(2) Home Visits for Mothers with Newly born Babies

- **Inquiries:** *Your local Health & Welfare Center*

After your child is born, please submit the "Birth Notice" using QR code on your Mother and Child Health Handbook. Please note that it is important to send this notice if a newborn baby weighs below 2,500g. According to the information given in the notice, a public health nurse or a midwife visits your home to check your baby's growth, including measuring your baby's weight, etc. They can also give advice on child-rearing or postnatal health issues.

(3) Postnatal Care Support

A midwife counsels on conditions of postnatal mother and baby, concerns and problems of childcare and gives advice for confident mothering. There are two types of postnatal care: home-visit care, in which a midwife visits the mother's home to provide breast care and advice on how to care for the baby, and overnight or day-care centers, in which the mother receives care at a midwifery facility.

(4) Child-Raising Classes and Consultation and Baby Food Workshop

Those eligible for the above vaccinations will be notified by mail. Please receive vaccinations at designated medical institutions within Itabashi. If vaccinations are received within the vaccination period or target age designated by law, the full amount charge are to be borne by public expenses (i.e. free of charge).

Kindergartens are for children between the ages of 3 and 5 years old, just prior to entering elementary school. In Itabashi there are 1 public and 31 private kindergartens. Guardians with children living in Itabashi who enroll their children in private kindergartens and pay the relevant fees may be eligible for a subsidy. In cases that guardians enroll in Itabashi or any vicinity, each kinder is ready to distribute subsidy application form which can be filled in and submitted to each institution. In other cases of enrollment outside Itabashi, the Educational Affairs Section sends information on the application to the relevant guardians.

School Education (Elementary School, Junior High School)

Japan has a "6-3-3-4" school year system: elementary (six years), junior high (three years), high school (three years) and college or university (four years). Attendance is compulsory from elementary through junior high school for a total of nine years (ages 6 to 15). The Japanese school year runs from April through March the following year. Children are required to enter elementary school in the first April following their 6th birthday.

Children of foreign residents are not obliged to attend school in Japan, but those interested in sending their children to a Japanese school are welcome to apply. Procedures related to enrolling in schools and the classes at schools are all conducted in Japanese.

According to the Resident Registration records, enrollment information is mailed to households with children who have attained school age in early September on entering school the following spring. Children continuing on to junior high school after attending elementary school in Itabashi receive information via their elementary school in early September. In the case the children are not enrolled at Itabashi municipal elementary schools, the information is mailed in early September according to Resident Registration.

Those who move into Itabashi City and would like their children to attend Itabashi public elementary or junior high schools need to complete paperwork at the Educational Affairs Section, Board of Education Office. Resident (Zairyu) Cards or Special Permanent Resident Cards and passport for the children in question are necessary to apply. Children who have already attended Japanese school at their previous residence is required to show the enrollment certificate and textbook certificate issued by their previous school.

Admission, tuition fees and textbooks are free at Itabashi public elementary and junior high schools. Guardians only need to pay for school supplies, school lunches and school trips. For further details, please inquire for more details.

National Health Insurance System

The National Health Insurance (NHI) (*kokumin kenko hoken*) is a public healthcare system which all residents of Japan are required by law to join in order to ensure that all individuals are able to receive medical treatment with peace of mind in the event of sickness or injury.

By law, all residents of Japan are required to join NHI if they are not already enrolled in their employer's health insurance scheme, and foreign nationals residing in Japan are also subject to this law. NHI is based on the principle of mutual assistance, where all enrolled members pay medical fees (premiums) proportional to their income in order to cover the medical costs of the insured.

(1) Enrollment

Individuals under 75 years old who correspond to any of the following are obliged to join NHI:

- Registered residents of Itabashi
 - ▶ Those who have entered Japan from abroad
 - ▶ Those who have moved into Itabashi from a different municipality
 - ▶ Those who have changed to a visa eligible for resident registration
- Registered residents
 - ▶ Those who have left their employer's health insurance program
 - ▶ Those who have stopped receiving public assistance
- Babies born in Japan

※Those with "Designated Activities" (*tokutei katsudo*) visa status, who are in Japan to receive medical care or to assist those receiving medical care, are not eligible to enroll in NHI even if they are registered residents. Those with "Designated Activities" visa status, whose period of stay is one year or less, and who are in Japan for the purpose of tourism, recuperation or other similar activities or those accompanying such individuals, are not eligible to enroll in NHI.

When you enroll in the National Health Insurance, NHI, you will receive either a "Certificate of Eligibility" or a "Notification of Insurance Qualification."

The "Notification of Insurance Qualification" is issued to those who have registered their My Number Card as a health insurance card, "Myna Health Insurance Card".

(2) Renewal Process for the Certificate of Eligibility (or Notification of Insurance Qualification)

The validity period lasts until the day after your residence status expires or September 30, 2025, whichever comes first.

(3) Loss of National Health Insurance

Those who correspond to any of the following must take procedures to leave NHI:

- ▶ Those who have joined their employer's health insurance scheme
- ▶ Those who have joined another health insurance scheme (including as a dependent)
- ▶ Those who have started receiving public assistance
- ▶ Those who leave Japan or move to a different municipality
- ▶ Deceased individuals

(4) Returning Health Insurance Cards

Those who leave NHI must return their insurance card. Those who continue to use the system to receive benefits even though they are no longer eligible will be subject to penalties.

The insurance card is not eligible after moving out of Itabashi City. If the insurance card is used after moving out, even by accident, the insurance benefit cost (70% of covered medical fees) must be repaid to Itabashi.

(5) Health Insurance Cards and Benefits

Upon joining NHI, you receive a 'National Health Insurance Card' (*kokumin kenko hoken hi-hoken-sha-sho*). When you visit a medical facility for treatment due to sickness or injury, the total cost of medical treatment is to be paid, in principal, 70% by NHI upon presenting the insurance card at reception; the remaining 30% must be paid by the individual. Only the insured individual whose name is written on the insurance card is entitled to use it. Once the individual has left NHI, the health insurance is no longer valid, even if the insurance card is within the expiration date. Insurance cards are not tickets, and may not be given or lent to any other individuals. The insured individual is eligible to receive fixed maternity and death benefits.

(6) Premiums (*hoken-ryo*)

Once enrolled in NHI, premium payments are levied on a per-household basis. Notifications for Premium are to be mailed addressed to the head of the household. Premiums is, in principle, to be paid as direct debit from bank account (Registration of bank account is required) .If not possible, it can be paid at City Office, City Residents' Offices, convenience stores and financial institutions. Credit cards(mobile Register) ,and such digital money as LINE Pay, Pay Pay, d-Barai Payment, au pay, J-Coin PAY are also acceptable. Individuals may be denied coverage or extension of resident status in case of delinquent payments of the premiums.

(7) Income Declaration

The premium is calculated according to the income of the previous year. Taking an example, in the case of new enrollment between April 1st, 2025 and March 31st, 2024, premium is calculated based on the income between January 1st, 2023 and December 31st, 2023.

Since there is an exceptional case of reducing premium according to the declared income, kindly requested to declare regardless of the amount of income. Without the declaration, the exception case cannot be applied to. You are requested to inquire taxation section of relevant municipalities the resident registered as of January 1st (in case of Itabashi resident, refer to P.16). For those residing in Japan for less than one year, inquire and consult at National Health Insurance & Pension Section, City Office South Building 2F #22.

(8) Procedures for Renewal and effective validity of National Health Insurance

The National Health Insurance card of Itabashi is renewed on October 1st of every odd year. Validity of the NHI for Non-Japanese is the following date of the resident permit or September 30th , 2025. In case of delinquency of premium payment, some cases may not be applicable. Once the period of stay has been extended, requested to take procedures for NHI accordingly with your resident card and passport. It is planned to integrate the NHI card with the My Number card and abolish the current NHI card in the fall of 2024. Details will be announced as soon as the National Government policy is decided. (As of November 1, 2023)

(9) Application Procedures for Change of Address, Name or Head of Household

As premiums are calculated on a per-household basis, individuals will need to undertake the necessary procedures in order to change their premiums and receive a new insurance card when there have been changes in the number of people in the household, the household head or the address.

National Pension System

The national pension (*kokumin nenkin*) system is provided mainly to guarantee a stable lifestyle for the elderly, sick, injured, and disabled. All residents of Japan aged 20 to under 60 years old are obliged to join, including foreign nationals residing in Japan. You can receive pension payments outside of Japan by remittance even when you no longer reside in Japan.

(1) Enrollment

Those who are aged from 20 to under 60 years old and registered as resident in Itabashi City and are non-participants of other public pension systems such as an employee pension system are obliged to enroll in the national pension system.

However, those whose status of residence is "engaged in designated activities" and whose purpose of stay is for medical treatment or as an attendant of the medical treatment person, or for sightseeing or recreational purposes staying for a long period of time or the spouse of the long-term visitor are not eligible.

(2) Pension Premiums

After enrollment, premiums must be paid monthly. Premium payment exemptions proportional to income may be possible in cases of financial difficulty. There is a payment exemption system for students; however, some educational institutions do not qualify. There might be some exemptions in such cases as giving births and receiving disability pension.

(3) Applicable Pension Types

① Old-age Basic Pension (*rorei kiso nenkin*)

In principle, individuals become eligible to receive this pension at the age of 65 if the period of payment of the premiums, the period of exemption from payment of pension premiums, or the combined total number of payment years is longer than 10 years (120 months). If the participant had previously participated in a different public pension program such as *koseinenkin*, this period is calculated as periods in which NHI payments were completed. Participants are eligible to receive the full amount of old-age basic pension if they complete the premium payment for 40 years between the ages of 20 and 60.

② Disability Basic Pension (*shogai kiso nenkin*)

Individuals become eligible to receive this pension when they are judged to have a level 1 or level 2 disability as determined by law due to illness or injury for which they first received treatment before the age of 20 or after they were enrolled in NHI.

③ Others: Survivor's Pension (*izoku kiso nenkin*), Widow's Pension (*kafu nenkin*), Lump-sum Death Payment (*shibo ichiji-kin*), Pensioner Support Benefit

It is also possible to receive various other pensions under certain circumstances.

※In order to receive ② or ③ above, basic payment requirements, in principle, apply.

※For Pensioner Support Benefit, inquire Japan Pension Service

(4) Loss of National Pension membership

If a person who is a member of the National Pension Plan leaves Japan, he/she needs to complete the procedures to discontinue the Plan.

Foreign residents who have paid national pension premiums for over 6 months are eligible to receive a refund in proportion to the period of premium contributions in case of leaving Japan without pension collection. The application for refund should be submitted within 2 years of departure from Japan to the Japan Pension Service.




Health Consultations and Examinations

Health Examinations

The City conducts health examinations of the four types listed below. Details about the dates and places of examinations and how to apply for them are announced in Newsletter “*Koho Itabashi*”. Individuals aged between 40 to 74 years of age receive their examinations under the health insurance policy in which they are enrolled. Individuals who are enrolled in a health insurance or who are listed as dependents are requested to inquire each health insurance provider.

(1) National Health Insurance Specified Examinations

Special health examinations for adult-onset and lifestyle-related diseases are conducted for individuals between the ages 40 and 74 who are enrolled in NHI in Itabashi. Examination coupons are sent to eligible individuals. Depending on the results of the examination, individuals may also receive special guidance either from the medical facility where they took the examination or from private healthcare institutions.

Individuals who have the opportunity to take equivalent examinations at their work, etc., are not eligible. Individuals who fulfill certain conditions may have the examination fee waived.

(1) Hepatitis Examination

To facilitate the early detection of hepatitis infection, to slow the onset of the disease and to prevent and minimize health disabilities due to it, individual residents in Itabashi aged over 35 who have not had an examination for hepatitis since 2002 are eligible for this examination.

(2) Osteoporosis Examination

The examinations to prevent and early detection of Osteoporosis are conducted for female residents at the ages of 40, 45, 50, 55, 60, 65 and 70. A charge of ¥500 applies.

(3) Ophthalmic Examination

Ophthalmic examinations for the prevention and early detection of ophthalmic disorders (including glaucoma and cataracts) are conducted for residents at the ages of 50 and 55. A charge of ¥700 applies.

(4) Dental Examination for adults

Dental examinations for prevention and early detection of periodontal diseases are conducted for residents at the ages of 40, 45, 50, 55, 60, 65 and 70. A charge of ¥500 applies.

(5) Cancer Examination

Cancer examinations for prevention and early detection of cancer are conducted for residents. A charge applies for stomach cancer (endoscope examination, ¥1800), breast cancer (¥1,000), laryngeal (throat) cancer (¥500) and gastric (stomach) cancer risk (¥500).

Don't you happen to have symptoms such as a persistent cough and phlegm for more than 2 weeks, continuous high fever, bloodstained sputum or spitting up blood? If the answer is yes, it may be tuberculosis.

If these symptoms appear, you should take a tuberculosis examination (chest X-ray, phlegm test) at a medical institution, even if you believe they may be due to smoking or a cold. There is a public health subsidy to cover the cost of tuberculosis treatment. You may receive counselling at Infection Control Measures Subsection, Disease Prevention and Infection Control Measures Section of Health Care Center.

Taxes

What are Taxes?

Government and municipal works relate to our daily life in many ways. The national government is engaged in infrastructure development and enforcement of economic and diplomatic policies that affect us on a national level, whereas municipalities cover welfare, education, health services, police and fire station services etc., which are managed at the community level. We share the burden in the form of taxes in exchange for these services.

(1) Income-based Tax

There are various kinds of taxes, among which Resident Tax (local tax) and Income Tax (national tax) are particularly directly related to each individual. The two taxes are different in rate and the former is based on the previous year's income while the latter on the current year's income.

①Resident Tax (*jumin-zei*)

The resident tax consists of two parts: a fixed amount or equal tax for those with income above a certain level and a variable amount or income-based tax calculated based on income. Additionally, starting in FY 2024, the national Forest Environment Tax is collected together with the resident tax to fund forest conservation and development initiatives.

Taxpayers

Itabashi Resident Tax must be paid regardless of nationality if you were residing in Itabashi City as of January 1st and earned personal income in the previous year.

Declaration

Please make a declaration of the previous year's income, etc. at Itabashi City Office Taxation Section, from February 16th to March 15th of every year. Exceptions apply to those who have already filed an Income Tax report at the Tax Office, or if you have received only employment income which has already been declared to the Tax Office through your workplace. Tax forms are available at the Taxation Section Counter.

Methods of Tax Payment

There are two ways by which one can pay Resident Tax: "Ordinary Collection", where taxes are directly paid by taxpayers, and "Special Collection", where taxes are paid on behalf of the individual through the workplace.

► **Ordinary Collection (*futsu choshu*)**

Resident Tax is calculated based on your tax declaration. Tax payment notification letter and tax payment slips will be mailed to your house around June 10th. The payment due dates are set for June, August and October of the same year and January of the following year. Taxes may be paid at City Office, City Bureau, convenience stores, Smartphones and financial institutions.

► **Special Collection from Salaries (*tokubetsu choshu*)**

Salaried workers will be notified by City Office through their workplace (or the place paying their salary) by notification letter of the amount of Resident Tax to be paid via Special Collection. Tax payments are then deducted from your salary every month (twelve payments from June to May of the following year), and companies undertake tax payments on behalf of the worker.

► **Special Collection from Public Pensions**

Residential Tax can be collected on public pensions via Special Collection from that year's public pension.

Income tax is a national tax handled by the Tax Office. You are required to file an income tax return when you have earned income, as all your individual income for the year is subject to Income Tax. Income Tax reports should be submitted to the Itabashi Tax Office from February 16th to March 15th. During the filing period, numbered admission tickets will be distributed at the tax office to manage crowding. If you need assistance with preparing or filing your tax return, you will need the ticket. (For consultations outside the filing period, an appointment is required.)

Municipal property tax is collected from those who owned land, houses or other depreciable assets as of January 1st, and is collected by the Tokyo Metropolitan Government Tax Office. The amount of tax payable is based on the assessed value of assets.

Motor vehicle tax is paid by those who own motor vehicles as of April 1st.

Individuals are required to present the following documents and receive a license plate when purchasing or transferring ownership of motorcycles.

- Sales receipt or disposal slip and receipt of transfer of ownership
- Seal and personal identification (My Number Card, Resident Card or driver's license)

Disposal

If you dispose of or transfer ownership of a motorcycle or move out of Itabashi City, you are required to notify City Office with the following documents.

- License plate of the motorcycle
- Registration certificate of the motorcycle
- Seal and personal identification (My Number Card, Resident Card or driver's license)

Nursing Care Insurance

The nursing care insurance (*kaigo hoken*) system was designed as a way of providing nursing care through mutual assistance by sharing its related costs. Individuals who have been certified as being in need of care are able to access the services they need, and recipients of the services bear a portion of the expenses incurred (10-30% depending on income).

(1) Enrollment in Nursing Care Insurance

All registered foreign residents aged 40 years or older and legally permitted to stay in Japan for longer than three months are required to join the nursing care insurance scheme.

Those who are over 65 years of age are primary participants, and those between 40 to 64 years of age are secondary participants. Nursing Care Insurance Cards are sent to the primary care participants. Please inquire the Nursing Care & Insurance Section in case the card is not with you regardless of your eligibility.

(2) Payment of Premiums (*hoken-ryo*)

►Primary Participants

Those who receive old-age pensions, retirement pensions etc. totaling more than ¥180,000 annually have their premiums deducted automatically from their pensions. Other eligible participants are required to pay with payment notice slip or via bank transfer. For those who find it difficult to pay premiums temporarily due to such special reasons as disaster, there are systems for extension of collection, reducing the amount and exemption.

*There are systems to apply reducing the amount for those who make a living difficult.

►Secondary Participants

Premiums are collected in a lump sum along with medical insurance premiums. The amount differs depending on the insurer.

- ▶ the application for care may be submitted in his/her place by one of the family members, home care providers or nursing care institutions.
- ▶ Applicants are notified of the result within approximately 30 days from the date of application.

- Wellbeing checks using the “Genki” (Vital Functions) check-sheet are offered to over 65s who are not certified as in need of care or support under the Nursing Care Insurance Scheme at Elderly Consultation Center to facilitate early detection of loss of mental and physical functions. Based on the data, information about “preventive care” workshops and services for independent living are offered for use.

Welfare Services for People with Disabilities

Individuals who have been issued with a physical, intellectual, or mental disability certificate etc. are eligible to receive various services depending on the degree of their disability.

Physical Disability Certificate (*shintai shogai-sha techo*)

This Certificate is issued to those who are physically disabled affecting the limbs, vision, hearing, balance, speech, language, chewing, heart, kidneys, liver, respiratory system, small intestine, rectum, bladder, or immune system.

This is issued to those who are intellectually challenged. The level of disability is classified on a scale of 1 (the most serious case) to 4 (mild case). For individuals over 18 years old they are issued by the Tokyo Metropolitan Government Rehabilitation Center for the physically and mentally disabled (TEL: 03-3235-2961).

The Latter Stage Elderly Healthcare System (*koki korei-sha iryo seido*) is a health insurance system that all registered residents aged 75 years or older are required to join. By submitting the Health Insurance Card, the payment of medical expenses becomes either 10%, 20%, or 30% of the total amount.

Insurance premiums are borne by all enrolled individuals. As with Nursing Care Insurance, in principle, premiums are deducted automatically from pension payments. However, depending on various conditions such as the amount of pension etc., in some cases you may be requested to pay by payment slip or automatic bank transfer.

Besides when a subscriber dies, a certain amount of benefit is provided to the person who performed funeral service.

Life Support and Welfare Funds

(1) Tokyo Metropolitan Single Mother and Single Father Welfare Foundation

Single-parent families who have lived in the Tokyo metropolitan area for over 6 months with dependent children under 20 years old are eligible for special loans in cases of financial need such as for business start-up costs, daily life, house repairs, medical treatment/nursing, school entrance fees and new employment. The annual interest is set at 0% or a very low rate, and the repayment period is from 3 to 20 years.

(2) Welfare Funds for Women

Single women under 25 years old or women over 25 years old who support their families are eligible for a special loan in cases of financial need, such as for business start-up costs, daily life, housing, school entrance. The annual interest is set at 0% or a very low rate and the repayment period is from 7 to 20 years.

※Applications for Welfare Fund Loans is judged; not all applications may be accepted.

Counseling for Livelihood Support

The general consultation counters at Social Welfare Offices offer consultation for those who are having trouble making a living. Please feel free to contact them.

(1) Livelihood Support for those with Financial Difficulties (Applicable to Foreign Residents)

Livelihood support is a system based on the Livelihood Protection Law designed to safeguard the livelihood of those with Japanese nationality who are experiencing lifestyle difficulties due to illness etc. using their own abilities and other methods. This law also is applicable to foreigners with specified residence statuses. You are to be interviewed to determine whether you are eligible for support or not. Even if you are not eligible, social workers will work with you to consider ways of assistance. In order to receive support, you are questioned the following:

- Residence status
- Family matters (parents, children, and siblings)

- Lifestyle (income, occupation, etc.)
- Residence (house owner, public housing, private housing, others)
- Assets (real estate, deposits and saving, life insurance, etc.)
- History of illness etc.

The law stipulates that the following should be prioritized and conducted prior to granting livelihood support.

- Utilization of assets, abilities and other possible ways of making a living
- Aliment from support obligors (i.e. Support from family/relatives etc.)
- Subsidies provided by other laws

(2) Counseling for Women

Counselling on women's issues and appropriate support is available in order to ensure that women can be financially and socially independent. Please feel free to request for help in case of domestic violence, problems related to pregnancy or childbirth, or seeking shelter.

(3) Family Counseling

Counselling is available on family relationship and life at home (divorce, marriage registration, recognition of illegitimate children)

- ③ As many Japanese people are not used to communicate with international residents, they may feel hesitant to speak as the first step. Please try to speak to the Japanese people when you have the opportunity.

(1) Waste disposal

In Itabashi, waste is collected from designated places (called Collection Points) (oversize garbage is collected in a different way. See the table below for details.). There are rules on how to dispose of garbage. Please use the designated Collection Point. If you do not know where to dispose of your garbage, please inquire the owner of the apartment, the management company (a real estate agent), or your next-door neighbors.

Please separate garbage into recyclable, combustible, and noncombustible. Please deliver to the Collection Point by 8:00 a.m. on the morning of the day of collection. Please do not dispose of garbage after collection is finished, on days when collection is not scheduled, or at night.

Collection days vary depending on your residential address. Please check the signboard at the Collection Point or inquire at the City Office or Sanitation Office. If you have any questions or problems about how to separate resources from garbage, or how to dispose of garbage, please contact the Sanitation Office in charge.

The maximum amount of garbage that can be disposed of in one collection is two to three garbage bags. If you wish to dispose of more than this, please inquire Sanitation Office for advice.


To those who dispose of garbage from their work





There is a charge applied for resources and garbage generated at work. You are required to purchase a fee-based garbage disposal ticket, “Shoriken” and affix it to your garbage bag. Please contact Sanitation Office before you send your work-related garbage to the city collection.

※Local Collection Points

Collection boxes are available at municipal facilities including Community Centers. Used cooking oil, cloth and clothing are collected at 14 locations: Itabashi Resource Recycling Promotion Section, East Itabashi Sanitation Office, West Itabashi Sanitation Office, Recycle Plaza, Ecopolis Center, Itabashi Tropical Botanical Garden, Sakuragawa Community Center, Fujimi Community Center, Shimurasakaue Community Center (Cloth and Clothing only), Akatsuka Branch Office, Oyaguchi Community Center, Manaport Narimasu (Narimasu Livelong Learning Center), Tokiwadai Community Center and MUJI at 22 Itabashi Minami-cho(Cloth and Clothing only). Used small electrical appliances are collected at Information Processing Center, Nakacho Fureai Hall and Takashimadaira Community Center in addition to the above 14 locations but excluding Fujimi Community Center, Shimurasakaue Community Center, Oyaguchi Community Center, Manaport Narimasu (Narimasu Livelong Learning Center) , Tokiwadai Community Center and MUJI at 22 Itabashi Minami-cho. Some supermarkets also collect trays or paper packs.

Non-collectable Items

▶Toxic, harmful, hazardous and extremely malodorous waste or articles that may pose an obstacle to collection or disposal cannot be collected. Such items should be returned to the shop where they were purchased or to the manufacturer. If you are not sure how to dispose of such items, please contact the sanitation office in your area for further information.

▶Examples of non-collectable items include gas cylinders, petroleum agents, industrial chemicals, printing ink, developing fluid batteries, fire extinguishers, fire-proof safes, medicines, soil, blocks, stones, sand, mortarboard, used oil, automobiles, motorbikes, tires (excluding bicycle tires), pianos, etc.

Community Recycle Collection

Community Recycle Collection is a volunteer activity initiated by town and residents' associations or apartment residents' group, not by municipal administration. Each group decides the activity dates and assembling points and collect such used items as papers, cardboards, clothes, and cans, etc., and hand them over to resource collection company. Please inquire if your community conducts the Community Recycle Collection to a person in charge of the associations or apartment residents' committee and follow the rules accordingly.

(1) Bicycle Parking

Leaving bicycles and motorbikes unattended on roads can be very dangerous to the elderly, small children, and wheelchair users as well. In case you need to park bicycle or motorbike around train stations, use the designated municipal or private parking areas.

For information on the locations and fees of City-operated bicycle parking lots, please visit the Itabashi City official website or call the Bicycle Parking Subsection of the City Office.

(2) Removal of bicycles and motorcycles left on roads

Leaving bicycles and motorbikes unattended on roads can be very dangerous to the elderly, small children, and wheelchair users as well. The City moves the bicycles and motorbikes up to 50cc left on streets administered by the City (including National Highways and Tokyo Metropolitan roads within the No Parking Zones for bikes and motorbikes) and takes them to designated storage facilities. In case your vehicle taken to a storage, requested to find out the storage location and claim it within one month. Unauthorized vehicles including motorbikes larger than 50cc parked in City-run bicycle parks are also subject to removal.

When claiming your bike or motorbike, you will need:

- The keys to your bicycle/motorbike
- An identifying document which can confirm the name and address of the person who has come to pick up the vehicle (passport, driver's license)
- Removal fee (bicycle: ¥4,300, motor bike up to 125cc: ¥6,600; motor bike over 125cc: ¥8,700)
- Bicycle impound pick-up hours: Daily 13:00-18:00 (excluding Dec.29~Jan.3 holiday period)
 - Motorbike and moped impound pick-up hours: Daily 10:00-17:00 (excluding yearend holiday period).
- There are four storage facilities across the City. Requested to inquire each facility below according to the relevant locations. If they are removed from other locations, please inquire the Bicycle Parking Subsection of the City Office.

(1) Owning a dog

Application for registration (issuance of dog tags) and issuing injection certificates are available at Healthcare centers, Health and Welfare centers and City Residents' Offices.

【Registration Application】

Dog licenses and rabies vaccination tags are issued at the Public Health Centers, Health and Welfare Centers, and City Residents' Offices.

ODog Registration

If you get a dog, you must register it within 30 days using one of the following methods, depending on whether it has a microchip:

- For dogs purchased from pet shops or breeders after June 2022, or dogs with microchips installed:

Please register your dog on the "Registration System of Microchip Information" website.

- For dogs without a microchip and no plan to install one:

You must obtain a dog license. (Registration fee: 3,000 yen)

Rabies Vaccination

Dogs must receive a rabies vaccination once a year between April and June at an animal hospital/Vet. After vaccination, bring the Vaccination Certificate to receive a rabies vaccination tag. (Issuance fee: 550 yen)

【Additional Important Rules】

①Keep your dog leashed.

Always keep your dog on a leash or properly restrained, including when taking it outside.

②Report dog bites immediately.

If your dog bites someone, you must report it to the Public Health Center within 24 hours and have it examined at an animal hospital within 48 hours.

③Clean up after your dog.

Have your dog use the toilet before walks. If your dog defecates while outside, you are responsible for cleaning it up.

<i>Scams on the Internet</i>	<p>In case you place an order on the Internet and pay for the goods, you do not receive it or the goods are fake.</p> <p>Responses to take: ・If the price is lower than usual, judge it carefully. Check the return policy.</p>
<i>Emergency Home Repair Services</i>	<p>Be cautious when hiring repair services for toilet clogs, water leaks, or lost keys. Some companies advertise low prices but may charge unexpectedly high fees.</p> <p>How to Protect Yourself:</p> <ul style="list-style-type: none"> ・When contacting a repair service, do not blindly trust the lowest price shown in online ads. Always confirm the work details, estimated cost, cancellation fees, and any additional charges before agreeing to the service. ・If you receive a bill that is significantly higher than expected, firmly refuse to pay on the spot and state that you will only pay an agreed amount later.


The Eco-Polis Itabashi Clean Ordinance sets rules for smoking in public areas. No littering of cigarette butts on roads or other shared public spaces. (It causes pollution and fire hazards.) Avoid smoking while walking or cycling. (It can burn people or damage clothing.) Smoking is prohibited in around eight designated areas of "No-Smoking Zones", including busy train stations and shopping streets. In the station vicinity, staff members patrol and provide guidance on these rules.

(2) Second-hand Smoke

To prevent unwanted second-hand smoke, smoking is controlled in public facilities where many people utilize according to Tokyo Metropolitan Ordinance and other relevant laws. At entrance of every restaurant, notice board on smoking is displayed.

Emergency Contact Information

When calling in, please remain calm and make sure to call from a safe location. If you feel danger during the call, please move to a safer location.

- **Inquiries:** *To report Crimes or Accidents → Dial 110*
 To report Fires and Medical Emergencies → Dial 119
 Assistance Service for sudden illness or injury and in case you are not sure whether to go to a hospital or call an ambulance. → Dial #7119 Tokyo Emergency Consultation Center

When you need to report a crime (*hanzai*) and/or accident (*jiko*), dial 110. This number is available 24/7 and is reachable from cellular phones. When you call this number, provide the following information to the operator:

- (1) **What happened:** Crime and/or accident
- (2) **Where it happened:** Name or address of the place in which the crime/accident has occurred
- (3) **Who is reporting:** Your name

※ If there is an injured person (*kega*), the 110 operator will arrange emergency medical services.

※ If you are calling from a cellular phone, the location and the phone number from which you are calling must be provided.

※ If you have become a victim of a crime such as robbery, report it immediately to the police. If your bankbook/credit card has been stolen, contact your bank and credit card company immediately to avoid further victimization.

To report a fire or illness/injury to the Tokyo Fire Department, dial 119. (Available 24/7). The following is the order of what to say when calling 119.

- (1) **What is happening:** Fire or medical emergency
- (2) **Where is it happening:** Location in which the emergency services are needed
- (3) **Who is reporting:** Your name

※ Let the operator of Police or Tokyo Fire Department know about any landmarks which may help emergency personnel find the location quickly.

※ If you call from a cellular phone, you need to provide the location and the phone number from which you are calling for sure.

Example : Reporting a Fire

In English

Q: This is the Fire Department.. Fire or Ambulance?

A: Fire.

Q: Where is the location or address fire engine should head for?

A: (Example) It is the ## Building at 1-3-5 Itabashi, Itabashi City.

Q: What is on fire?

A: (Example) The office on the 3rd floor. (Tell me specifically what is burning.)

Q: Okay. We're sending the emergency services.

In Japanese

Q: Shobo-cho. Kaji desu ka? Kyukyu desu ka?

A: Kaji desu.

Q: Nani-ku, nani-machi, nan-chome, nan-ban, nan-go desu ka?

In Japan, many small community police stations (*koban*), etc. are also located in different areas. Police officers working in these *Koban* provide various services: patrolling the neighborhood, taking reports (crime, missing persons, etc.), dealing with lost and found items, giving directions and so on. These *koban* act as “mini-police stations.”

(2) Not to become victims

Sneak thieves (*Akisu*)

The most common way for a burglar to enter a house is through the unlocked entrance. Since the burglar usually look for entrance doors or windows unlocked, lock them securely. Against the case of breaking windows, it is effective to install auxiliary locks above and below the main lock of the windows. These locks are inexpensive and can be easily installed.

- ▶ Make sure to lock your doors even when leaving the house for a short time, such as when putting out the waste or doing some quick shopping.
- ▶ Locking bathroom windows and doors is also important.

Prevent Bicycle Theft

There are many bicycle thefts in the City. Follow the advice below just to prevent yourself from becoming a victim.

- ▶ Lock your bicycle, even when you are away for a short time.
- ▶ Double locking.
- ▶ Do not park on the street. Park in a designated parking space.
- ▶ Complete crime prevention registration at bicycle shops.

If You Do Become a Victim

- ▶ Take care of yourself (might be a weapon involved) and seek out help.
- ▶ Call 110 and provide the location and details about the criminal (sex, height, clothes, vehicle, etc.)

Lost and Found (*wasuremono, otoshimono*)

In case lost or left something on public transportation, contact the closest station. Lost something in the street, required to contact the closest police station or *koban*. After a certain period of time all lost property is forwarded and stored at the Metropolitan Police Department Lost & Found Center.

Traffic Accidents (*kotsu-jiko*)

No matter how serious the accident you were involved in, call 110 and must be reported to the police. If some injuries involved, request help or ask to arrange an ambulance. Even if there is no visible or apparent injuries involved, serious aftereffects might follow. If hit or injured by a vehicle, go to hospital and receive treatment. After a traffic accident, take the following actions immediately and prevent multiple accidents.

In case other party involved, ask him/her as follows.

- (1) Ask for the driver's license and take notes of the license and registration number, name, address, age and telephone number.
- (2) Note the license number with their insurance document including insurance number.
- (3) If there was a witness, ask for the person's name, address and contact number.

Earthquakes

Everyday Preparations

It is very common to experience earthquakes in Japan as it is a volcanic country. Therefore, it is vital for you to be calm and prepared for earthquakes in your everyday life.

※An earthquake is the violent shaking of the surface of the earth that occurs when tectonic plates cross their respective fault lines.

When Earthquakes (*jishin*) Occur

Stay calm and do not panic. Obey the following rules. Your everyday preparations are important.

Indoors

- ▶ Crawl under a table to secure your safety, especially from falling objects.
- ▶ Put out fires in the area after the main shaking subsides and open the doors and windows to secure an exit.
- ▶ Do not rush out of the building. Be careful of falling objects when you go outside.
- ▶ Do not use elevators.
- ▶ Obtain accurate information from reliable sources such as the radio and act accordingly.
- ▶ Do not get confused or misguided by inaccurate information or false rumors.

Outdoors

- ▶ Be careful of falling objects such as glass and signboards and stay away from walls and other objects that may collapse.

- ▶ Act according to the directions given by authorities if you are in a public place.
- ▶ Pull your car over to the left and evacuate. Leave the key in the ignition in case the car needs to be moved by the authorities such as the emergency services.

Home Safety Measures

Fix your furniture to avoid it falling over or collapsing. The level of the earthquake can be higher than you actually feel or expect. Falling furniture is a common occurrence in earthquakes. In the Great East Japan Earthquake in 2011 it occurred in 16.8% of homes on the 1-2 story, 23.8% of homes on the 3-5 story, 31.9% of homes on the 6-10 story, and 47.2% of homes on the 11th story or above. (Figures taken from survey results from a survey by Tokyo Fire Department after the Great East Japan Earthquake, 2011)

Emergency Kits

Prepare an emergency kit containing emergency supplies such as flashlight, radio, food, drinking water, medicinal supplies, valuables etc. Store this emergency kit in a convenient place that is easy to access. Canned food is handy in case there is no electricity, gas or water as it does not require cooking. Prepare sufficient drinking water for 3 days. It is estimated that 3 liters per person per day should be sufficient. If you have babies or elderly family members, remember to include milk and diapers etc.

Talk with your Family

Take time to talk with your friends and family members about what to do when a large earthquake happens. Decide where and how to evacuate, and how to contact each other in case telephone lines are not available.

If you got injured at the time of disaster

If you got injured during a disaster, just head for Emergency Medical Aid Centers that will be opened in 13 locations in the City. EMACs will be opened in front of Disaster Base Hospitals and Disaster Base Cooperative Hospitals. Please refer to P8-P9 for their locations.

Levels of Earthquake

Refer to the following seismic scales to get an idea of what is likely to happen with different intensity levels. The seismic scales shown below illustrate some of the estimated damage for each level. It is important to know that the actual damage can vary even with the same intensity level depending on the location. The official announcement of an earthquake's seismic intensity provided by the Meteorological Agency is based on their official measurement system and not based on visible damage caused by earthquakes.

Level 4	Most people wake up, hanging objects sway, dishes in cupboards make clattering noises, and people riding bicycles can feel it.
Level 5 (weak)	Most people feel afraid and attempt to grab on to something for stability. Dishes and books on the shelves fall, and furniture may move. Telephone poles visibly sway, and concrete walls can crack.
Level 5 (strong)	Most people try to grab something for stability and experience difficulty walking. The number of objects falling from shelves and cupboards increases. Unsecured furniture may fall over, driving may become difficult and some cars may stop in the road.

Level 6 (weak)	People experience difficulty standing and most unsecured furniture moves or falls over. Doors may get stuck or not open, and tiles and windows may shatter and fall. Cracks may open in the ground and landslides may occur.
Level 6 (strong)	People can only move by crawling, most unsecured furniture moves or falls over, glass and tiles fall from buildings and the number of buildings collapsing increases. Large earthquake fissures appear.
Level 7	People cannot move of their own volition due to severe shaking. Unsecured furniture moves or falls over, tiles and glass shatters and falls, and the number of collapsing buildings increases. Large landslides may occur, and entire mountains sometimes become deformed.

Preparing for Floods

After heavy rains, there are possibilities of river floods and overflowing water from manholes. Shall we prepare sandbags for floods?

Region-Wide Emergency Evacuation Areas

Large parks and plazas etc. have been designated as areas to go to for protection during large fires caused by earthquakes, etc. There are twelve such areas in Itabashi including Ukima Park and Arakawa Green Zone. There is also one designated residual area in Takashimadaira which does not need to be evacuated even in case of fire as it has been fire-proofed and there is no worry of fires extending into its area. It is important to remember where these locations are ahead of time.

Evacuation Centers (*hinanjo*)

Evacuation centers are places that provide temporary accommodation for people who have lost their lifelines and relevant facilities and cannot go back home due to earthquakes, flooding, etc. They will serve as a base for information and food distribution. Local elementary and junior high schools are designated as such areas. Make sure to evacuate to somewhere safe.

When and Where to Evacuate

- ① First, go to a wide open and safe space such as a park or a vacant lot or wasteland nearby, and wait and see what happens.
- ② If your building or the buildings around you started to fall down and you had difficulties to go home due to fire, then go to one of the evacuation sites listed such as schools.
- ③ If you think that your house or the local evacuation area may be dangerous due to fires, etc., move to one of the region-wide evacuation areas. When you need to evacuate, the instructions for the elderly and others will be announced via community wireless systems, Itabashi Emergency Report email, City Website, City Twitter(X) or Itabashi Official Messenger App LINE, etc.


Evacuation Centers for Flooding

This is the shelter in case of major flooding. Elementary Schools and Junior High Schools are designated as Evacuation shelters. Since the facilities might be changed according to each condition of disaster such as scale of typhoon, location of evacuation center should be double-checked on TV or the City Website in the disaster.

* The City Office prepares Disaster Prevention Map and Flood Hazard Map indicating each evacuation center. Please make sure the location of your evacuation center just for the time to come.

Itabashi Emergency Disaster Center

The Itabashi Emergency Disaster Center is the center of preventive activities in Itabashi, and has worked on setting up the latest in wireless disaster announcement systems, cameras, weather information and other information collection systems. The Center is on 24/7 information watch in order to protect both the lives and property of Itabashi residents. You can also visit the Center if you make a reservation in advance.



(2) Itabashi City Industrial Loan System

Small-and-medium sized enterprises in the City or those who are planning to start business in Itabashi can borrow funds necessary for business management at a low interest rate from financial institutions that have contracts with the City. Either corporate or individual businesses are eligible, but corporate businesses must have their headquarters and activities registered and functioned in the City, and individual businesses must have their main sales office in the City of Itabashi on their tax returns.

In addition, in order to reduce the burden on borrowers, a portion of the interest is subsidized ("interest subsidy").
